**Check one:**

**BULK WATER PERMIT** - This permit includes bulk water supplied to fill tank trucks from the water system. All water shall be metered or tanker size must be known.

1. Bulk haulers must load at the Fire Department located at 5791 Lacy Rd. - 278-2980.  
(Water fill connection is located in back of the Fire Department) OR at the small single nozzle fill hydrant located at the corner of Lacy Rd and Jones Farm Rd. It is painted blue with a large sign in front of it.
2. Bulk haulers must provide own 2½" standard fire hydrant hose connection from the fire hydrant to the tanker and wrench.
3. Return your permit when project is completed with total amount of water used.

**METERED HYDRANT PERMIT** - This permit shall allow the use of water at a construction site through a metered fire hydrant connection. *The meter and connection shall be provided and installed by Utility personnel only.*

1. Hydrant must be fully opened. Use gate valve to throttle flow. Shut off hydrant after use each day.
2. Contractor shall notify the Utility office as soon as the meter is no longer needed.
